General Information

Considering the provisions of *Council Regulation (EU) No 833/2014 concerning restrictive measures in view of Russia's actions destabilizing the situation in Ukraine, as amended,* following applies to the air carrier:

- 1. The aircraft must NOT be owned or chartered, or otherwise controlled by any Russian natural or legal person, entity or body and that there are no persons on board the aircraft listed in Annex to the *Council Implementing Regulation* (EU) 2022/427².
- 2. The charterer of this commercial air transport operation must NOT act as an agent on behalf of any natural or legal person, entity or body that is subject to the abovementioned Regulations.

We must emphasize that violations of the provisions of said Regulation are subject to sanctions.

- → Block permit is applicable only to ad-hoc 3rd and 4th freedom of the air traffic rights in non-scheduled international air services.
- → The air carrier must keep record of all flights operated under this Block permit and submit it to the Agency before its renewal.
- → The air carrier shall not operate permitted services using wet leased in aircraft unless specifically authorized by the Flight Authorization Section.
- → Safety related documents must be uploaded and up to date on EASA TCO web interface³ and Environmental Portal⁴.
